COURSE REQUIREMENTS

Attendance: The state of Idaho requires all students attend 90% of the course to pass. <u>Students need to make necessary arrangements to avoid conflicts with the course dates/times (work, other classes, etc.)</u>.

CPR: Student shall maintain current certification of American Heart Association (AHA) Healthcare Provider (HCP) CPR throughout the clinical portion of the course. To schedule a CPR class visit https://workforcetraining.isu.edu or call (208) 282-3372. Students who have taken CPR, but not AHA Healthcare Provider CPR, must return to the CPR training center to get documented verification of: 1) concepts taught; 2) successful completion of both a skills test and written test.

Hepatitis B Vaccine/TB Test: Prior to clinical, each student shall provide proof of:

- One of the following: 1) at least the first dose of hepatitis B vaccine; 2) a positive titer indicating immunity to hepatitis B; 3) documented refusal of the hepatitis B vaccine. Note: The three-shot series provides life-long immunity.
- A negative TB test administered within one year of clinical start date. For positive TB tests: Student must provide a
 physician's note releasing student to care for vulnerable populations. Note: This is a skin test that takes three days
 from administration to evaluation.

BACKGROUND CHECK

ISU CNA does not perform background checks, but students can expect one once hired by an agency after testing is complete. If we are informed of a past crime during the course, we must inform our agency and allow them to decide if the student can rotate. If denied clinical, the student will be ineligible for reimbursement or transfer. Information of this nature is included on the Idaho Criminal History Unit website at https://chu.dhw.idaho.gov/.
