<u>Course Days/Hours</u>: This is a hybrid course, with classroom learning occurring online. Lab Days will be 5:30-8:00 p.m. Tuesdays and Thursdays. 40 hours of clinical will occur at a clinical agency (based on agency availability – will NOT be during normal class hours; see below).

## **COURSE REQUIREMENTS:**

AGE: Must be at least 18 to enroll.

**ATTENDANCE:** Students are allowed up to 12 hours of missed class time with 100% make-up required. Students need to make necessary arrangements to avoid conflicts with the course dates/times (work, other classes, etc.).

**BACKGROUND CHECK:** The cost of the background check is included in the course fees. Passing or failing the background check is dependent on the type of crime(s) and/or when the offense occurred. Information of this nature is included on the Idaho Criminal History Unit website at <a href="https://www.chudhw.idaho.gov/">https://www.chudhw.idaho.gov/</a>. If a crime is on the list as a disqualifying offense, the student cannot enter clinical; therefore cannot pass the course and is ineligible for refund or transfer of fees.

**CLINICAL:** The course end date is <u>highly</u> subject to change. Each student must have 100 blood draws and 40 hours of clinical. If more time is necessary to obtain 100 blood draws, the course end date must be delayed. Clinical occurs throughout Southeast Idaho and may be scheduled any time of day or night. At least one month advance notice will be provided. Students must provide own transportation and instructor cannot schedule two students at the same location.

**CPR:** Student shall maintain current certification of **AHA BLS Provider CPR** throughout the clinical portion of the course. To schedule a CPR class visit <a href="https://cetrain.isu.edu">https://cetrain.isu.edu</a> or call (208) 282-3372.

**IMMUNIZATIONS/TB TESTING:** The clinical agency requires all students to provide evidence of immunity to Hepatitis B, measles, varicella, mumps & rubella (MMR), and a negative TB test. Details provided the first day of class.

**DISABILITY ACCOMMODATIONS:** Reasonable accommodations can be made for those who have a documented disability, which may affect performance in class. Unless we receive written notification from the ISU Disability Services Office at 282-3599 within one week after the beginning of class, we may not be able to assist in a timely and appropriate manner.
